BEST TRAINEE COMPETITION

The 48th Annual Scientific Session and Meeting of the Delaware Valley Vascular Society will be held on Thursday, April 9, 2026 at the Union League of Philadelphia. Abstracts to be presented at this meeting are now being requested from DVVS Members and residents/fellows and students in training. The Society also invites our Associate Members to submit your work. As this is a local meeting, we will accept abstracts that have been presented or submitted to a national or regional meeting already.

ABSTRACTS

Abstracts should be full-length presentations in areas of clinical and basic science research, as well as clinical reports of significant interest in the care of patients with vascular diseases including vascular practice management issues and other related topics relevant to all DVVS Members.

The Program Committee will be accepting abstracts that highlight, but are not limited to the following topics: the management of aortic aneurysms; technical implications of endovascular repair of aortic aneurysms; management of carotid disease, device technology and development; relationship of basic science research to clinical practice; the role of preoperative non-invasive and invasive imaging in the management of occlusive and aneurysmal disease; hemodialysis access; and any topics related to peripheral arterial disease, venous disease, and wound care.

BEST TRAINEE AWARD

Abstracts presented by our Trainees will be eligible for the Clinical Research Award, Basic Science/Case Report Award and Medical Student Award.

Trainee-presented abstracts will be considered for the Clinical Research Award and the Basic Science/Case Report Award. This year, there is a new eligibility category for the Medical Student Award, specifically for those presenting in the medical student category.

DVVS members will conduct the review and scoring of these presentations. There will be monetary awards, as well as certificates presented to each winner at the evening dinner.

Please encourage your students and trainees to submit an abstract for this award.

Please carefully review the instructions for submission. The Abstract Submission deadline is **Monday, January 12, 2026.**

Please include a COVER PAGE (first page of submission document) with the following, *REQUIRED* information in order for your abstract(s) to be considered.

- > Title of Abstract
- Abstract/Case Institution
- Primary Author's Name
- Please confirm if Author is a DVVS Member, Associate Member, Non-Member, Resident-Fellow or Student
- Mailing Address of Primary Author along with telephone, fax numbers and email address (if different than author who is submitting by email)
- Name of the Presenter
- > Whether the abstract is a Case Report, a Clinical Abstract, or a Basic Science Abstract
- List all Authors in the order that they will appear on the paper
- > If none of the authors are members of the Delaware Valley Vascular Society, the name of a Member Sponsor must be provided.
